First Party: Nordic Sport AS

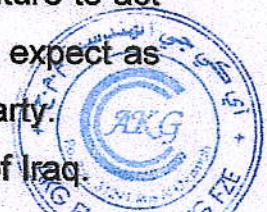

The two parties agreed as follows:

- 1- To cooperate as a consortium to implement the Police Club Sport Complex Project in Baghdad which belongs to the Ministry of Interior?
- 2- Each party declares to have the means and Technical knows – how required for the performance of the project as set forth in this agreement.
